

## TERRAVUE™ HERBICIDE WORKS SWEEPSTAKES

### OFFICIAL RULES

NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. SWEEPSTAKES DESCRIPTION:** The TerraVue™ Herbicide Works Sweepstakes (the “Sweepstakes”) begins on 6/8/20 at 12:00:00 AM Central Time (“CT”) and ends on 9/30/20 at 11:59:59 PM (CT) (the “Sweepstakes Period”). Throughout the Sweepstakes Period, eligible entrants will have the opportunity to enter the Sweepstakes via Twitter by retweeting the promotional advertisement along with a short comment and the Hashtag, as more fully described below. Completing an entry on Twitter with a comment along with the Hashtag will be defined as a “Submission” in the Sweepstakes. There will be ten (10) prizewinners in the Sweepstakes who will be randomly selected at the end of the Sweepstakes Period from all eligible entries submitted.

By participating in the Sweepstakes by completing a Submission on Twitter, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Corteva Agriscience (“Sponsor”), which shall be final and binding in all respects.

- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the states of Alabama, Arkansas, Colorado, Florida, Georgia, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Mexico, North Carolina, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia, Wisconsin and Wyoming who are twenty-five (25) years of age or older at time of entry and are a Roadside Manager, work in Vegetation Management or Utility ROW. All Submissions must be retweeted/posted to a nonprivate Twitter account and you MUST include the Hashtag with your Submission to be eligible as an entry in the Sweepstakes. You must be a registered Twitter member to enter. Twitter account registration and Sweepstakes entry is free.

**Direct any questions, comments or complaints regarding the Sweepstakes to Sponsor, not Twitter.**

Each Submission must meet the following “**Submission Requirements**” (any Submission that, in Sponsor’s sole and absolute discretion, violates the following criteria will be disqualified):

- Submissions must be posted to a nonprivate Twitter account. Twitter account can be obtained for free at the Twitter website or in the applicable app store;

Limit one (1) entry per person/Twitter account, per day in the Sweepstakes. **Any entries in excess of this limit will be deemed void.** For purposes of these Official Rules a “day” is defined as any twenty-four (24) hour period during the Sweepstakes Period beginning at 12:00:00 AM (CT) and ending at 11:59:59 PM (CT). Any entrant who attempts to enter more than entry limit, as provided for in these Official Rules, during the Sweepstakes Period by using multiple social media accounts and/or under multiple identities will be disqualified from participation in the Sweepstakes and all entries from that individual will be considered void. Sponsor is not responsible for any change of mailing address, email address and/or telephone number of entrants. In the event of a dispute over the identity of an entrant in the Sweepstakes, entry will be deemed completed by the authorized account holder of the social media account provided at the time of participation as long as such person is otherwise eligible in accordance with these Official Rules. “Authorized Account Holder” is defined as the natural person who is assigned to a social media account by the social media platform or email address by an internet access provider, online service provider, wireless carrier, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Potential winner may be required to provide Sponsor with proof that he/she is the Authorized Account Holder of the social media account or email address associated with the winning Sweepstakes entry. If a dispute cannot be resolved to Sponsor’s satisfaction, the affected Sweepstakes entry will be deemed ineligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. Each entrant hereby agrees to indemnify and hold the Sweepstakes Entities harmless from and against any and all third-party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of entrant hereunder.

Potential winners will be notified via direct message on the social media channel associated with their entry within seventy-two (72) hours of the random drawing with instructions on how to verify eligibility and claim the prize using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by the potential winner for any reason.
